If you wish to appear in person for public input:

Facemasks are required for the safety of others and to minimize the spread of COVID-19. There will be a sign-up sheet in the lobby of the Town Hall where you will sign in and place what agenda item that you would like to speak regarding.

Anyone wishing to speak in person must sign in on the sign in sheet no later than five-fifty (5:50) p.m. on Wednesday, August 12, 2020.

In order to maintain six (6) feet of social distancing those who have signed-up for public comments will remain in the community center and will be escorted into the meeting room when it is their turn to speak.

Only one (1) person will be allowed to speak at a time.
